a) NG911 Update

Mrs. Stromberg updated the committee on current status of 911 updates taking place. Currently there are three (3) simultaneous 911 projects in progress.

a) Multi-Part Replication

WinGIS is working with Esri to remedy an issue brought to our attention by the Supervisor of Assessment's department regarding parcel numbers from Multi-part parcels not being replicated.

b) New Maps

The "Community Development" map is being created to serve the needs of individuals in our member agencies who require both property search layers as well as utility information as they pertain to economic development.

A new Safety Map will be created to fill the void left by the 911 map that was initially created for the Winnebago County Sheriff's Department but removed when they no longer had a need for it.

OTHER MATTERS

- Mr. Oelschlager inquired if WinGIS would be willing to pay for the hotel for two employees of the City of Rockford so they could attend the National Security and Public Safety Summit portion of the 2020 Esri User Conference. Mr. Gregg indicated that his initial thought would be that it would be ok, provided no other agency wanted to take advantage of WinGIS' standing offer each year to cover the hotel cost for 1 employee from 2 agencies to attend the conference. Mr. Gregg reiterated that it was his initial thought and would give the idea some more consideration. He went on to solicit any opinions from other Tech Committee members either at the meeting or, if they wish, in private.
