### **OLD BUSINESS**

#### **a) 2021 Aerial Images**

- a. The Technical committee aerial photography Subcommittee scored 4 results ranging in price from \$38K to \$60K. The group consistently had Kucera and Aerial Services as their top two, with Kucera as the winner. Mr. Gregg reached out to Dave Peters as he was the contact for McClean Co when Kucera provided their aerial photography. He said they did a great job and they (MClean) were happy with the final product. He said while they delivered on time, they could have communicated progress a little better. Mr. Gregg also noted that Kucera offers 2" machine generated contours for \$11K as opposed to full edit contours for \$38K. We asked for clarification on the difference as well as if we could see samples. Since contours are so expensive we were going to either budget for them next time or attempt to derive them ourselves from the free State data. If the machine edit are acceptable, we could get aerials and contours for \$49K.

#### **b) Control Monument Inventory Follow Up**

- a. Ayres & Associates followed up with Mr. Gregg and committed to providing a quote to WinGIS for replacing missing monuments that were noticed during last spring's control monument inventory.
